REPORT/PARAWISE COMMENTS ON BEHALF OF RESPONDENT NO. 2 (FIA)

Respectfully Sheweth:

Preliminary Objections

That the instant petition is liable to be dismissed on the following scores:

- i). The steps taken by FIA are fully fortified by section 5 of the FIA Act, 1974, empowering this Agency to inquire into and investigate the offences, which are on schedule of FIA. Section 20 (1) of Prevention of Electronic Crimes Act (PECA), 2016 is FIA's scheduled offence, as the preceding Act is on FIA's Schedule.
- Instant FIR No. 01/2017 was registered by the PS FIA, Counter Terrorism Wing (CTW) Islamabad under Section 20 (1) of Prevention of Electronic Crimes Act (PECA), 2016 on the basis of enquiry No. 23/2017 in accordance with law.
- The facts leading to instant case are that, as stated above, the iii). instant FIR was registered on the basis of enquiry on the specific allegations that a campaign of vilification and character assassination by some unknown individuals has been illegally, unauthorizedly, dishonestly with malafide intention and ulterior motives, started on Internet using social media i.e. Facebook & Twitter etc. by disseminating / spreading / uploading defamatory / objectionable and disgraceful material / contents against the Government of Pakistan, Armed Forces of Pakistan and top brass of Pakistan Army etc. Such illegal activities are causing disharmony and unrest among different government institutions as well as inciting hatred and contempt against Government and state institutions. Prima facie, a case was made out under Section 20 (1) of Prevention of Electronic Crimes Act (PECA), 2016. Hence, the instant FIR was/has been registered against unknown persons. Further investigations are underway. Besides, the technical experts are conducting technical analysis & profiling of the social media users including that of Twitter & Facebook etc, who are suspected to be involved in the questioned vilification campaign.
