Figure III: Number of cases registered in every district of Karachi. As per above figure, eighty-eight (88) cases have been registered in Karachi in total out of which fifty-nine (59) cases are pending, nineteen (19) have been disposed off by merit, seven (7) cases disposed off after a compromise and three (3) cases have been kept in abeyance after accused persons absconded. Out of the pending cases, three (3) accused persons are in police custody, fifty-one (51) are out on bail, accused persons in two (2) cases have absconded while the status of the accused persons in three (3) cases is unknown. Out of the disposed-off cases, accused persons have been convicted in four (4) cases and acquitted by merit in fifteen (15) cases. Out of the fifteen (15) cases leading to the acquittals by merit, accused persons were acquitted in six (6) cases after complete trial, proceedings were stopped under section 249 CrPC in seven (7) cases, accused was discharged in one (1) case under section 243 CrPC and one (1) FIR was disposed off in c-class.

Figure IV: Attendance record of FIA officials in each case. Many times cases are adjourned solely because the investigation officers (IOs) or prosecutors are not present or do not produce relevant case material or case property. Cases that are cognizable and where the state is a party, the state prosecutor's presence is required to run them while the IO must be present with the case file.

*Case called: Number of times a case is called to be heard and parties are informed beforehand usually on the previous date of hearing. These exclude office diaries written to record receipt of letters, replies or any other update in the case. Previous updates included office diaries written to record updates.
